



Programme for the Issuance of asset backed securities

This supplement (the “**Supplement**”) is supplemental to, forms part of and must be read and construed in conjunction with the Base Prospectus dated 20 MAY 2025 (the “**Base Prospectus**”) prepared by SIA “VIAINVEST Assets” (the “**Issuer**” or the “**Company**”) with respect to Programme for the Issuance of asset backed securities of EUR 10,000,000 (ten million euro) and constitutes a supplement for the purposes of Article 23 of Regulation (EU) No. 2017/1129 (the “**Prospectus Regulation**”).

Terms given a defined meaning in the Base Prospectus shall, unless the context otherwise requires, have the same meaning when used in this Supplement.

This Supplement has been approved by the Bank of Latvia (in Latvian - Latvijas Banka) as competent authority under the Prospectus Regulation. The Bank of Latvia only approves the Base Prospectus, as supplemented by this Supplement, as meeting the standards of completeness, comprehensibility and consistency imposed by the Prospectus Regulation. Such an approval should not be considered as an endorsement of the Issuer or the quality of asset backed securities that are the subject of the Base Prospectus.

The Issuer, represented by the member of its Management Board, accepts responsibility for the information contained in this Supplement and declares that, to the best of its knowledge, the information contained in this Supplement is in accordance with the facts and makes no omission likely to affect its import.

Save as disclosed in this Supplement, no other significant new factor, material mistake or material inaccuracy relating to information included in the Base Prospectus has arisen or been noted since the publication of the Base Prospectus.
